RULES COVERING PERMITS FOR ATHLETIC FIELDS ATHLETIC PERMIT GUIDELINES

1. Please clean the area of litter before leaving site. A fine will be assessed and/or Permit Status Revoked.

2. Permittee is responsible for parking in designated areas only, not on grassy lawns or walkways.

- 3. Risk Management approval prior to athletic play/permit issuance.
- 4. During specific seasons, parks may be closed to vehicular traffic.

5. Prohibited: ALL ALCOHOLIC BEVERAGES, glass, containers and bottles.

6. No transfer of Permit (s) are Allowed.

7. The permitted area may be unavailable for an event or a portion thereof because of fire, flood or other emergency over which the park has no control. The Department of Parks because of emergency may find it necessary to cancel, postpone or move the field location. The County of HUDSON and its agents shall not be liable to indemnify or reimburse the permittee of any damage or loss arising because of such an emergency action.

8. Failure to comply with the Hudson County Department of Parks regulations and guidelines may result in cancellation of permit or denial of future permit requests.

9. Hudson County Parks Department has the right to revoke and/or changed permit (s) at any time.
